Whereas certain draft rules proposed to be made under section 306 read with sub-sections (3) and (6) of section 72 of the Goa Municipalities Act, 1968 (Act 7 of 1969) (hereinafter called as the "said Act") were published as required by sub-section (3) of said section 306 of the said Act, in the Official Gazette, Extraordinary, Series I No. 2, dated 12-4-2007, under Notification No. 10/109/85-DMA/89 dated 11-4-2007, of the Department of Urban Development (Directorate of Municipal Administration), Panaji, inviting objections and suggestions from all persons likely to be affected thereby within 15 days from the date of publication of the said Notification in the Official Gazette;

And whereas the said Gazette was made available to the public on 12th April, 2007;

And whereas no objections/suggestions have been received from the public on the said draft rules by the Government.

Now, therefore, in exercise of the powers conferred by section 306, read with sub-sections (3) and (6) of section 72 of the Goa Municipalities Act, 1968 (Act 7 of 1969), and all other powers enabling it in this behalf, the Government of Goa

hereby amends the Goa Municipalities (Common Accounts Cadre of Municipal Employees) Recruitment Rules, 2006, published in the Official Gazette, Extraordinary No. 6, Series I No. 4, dated 2-5-2006, under Notification No. 10/109/85-DMA/224 dated 2-5-2006, as follows, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Municipalities Common Accounts Cadre of Municipal Employees) Recruitment (First Amendment) Rules, 2007.

(2) They shall come into force at once.

2. *Amendment of the Schedule.*— In the Schedule appended to the Goa Municipalities (Common Accounts Cadre of Municipal Employees) Recruitment Rules, 2006.

(i) in column number 1,— against name and designation of post "Accounts cum Administrative Officer", in column No. 11, for the expression "Promotion: Assistant Accounts Officer with 5 years regular service in the grade", the expression "Promotion: Assistant Accounts Officer/Accounts and Taxation Officer, with 5 years regular service in the respective grade" shall be substituted;

(ii) in column number 1,— for the expression "Assistant Accounts Officer", the expression "Assistant Accounts Officer/Accounts and Taxation Officer shall be substituted.

(iii) in column No. 11,— for the expression "Promotion: Accountant with five years service in the grade", the expression

1. "Promotion: Accountant/Tax Superintendent, with 5 years regular service in the respective grade" shall be substituted.

(iv) in column number 1, — for the word "Accountant", the word "Accountant/Tax Superintendent" shall be substituted.
